- 5. Delegations & Presentations
 - a) Ian Duff & Juliana Serje (McSweeney & Associates) Economic Development Strategy Focus Group Session

Mr. Duff and Ms. Serje provided Committee with an overview of the economic development strategy update; specifically outlining the Top 10 priorities from the 2012 strategy and what has been accomplished. Ms. Serje summarized the statistical data used to compare the Township to the Provincial standard, including demographics, labour force, and location. Mr. Duff and Ms. Serje presented their summarized findings related to the Township's strengths,

challenges, opportunities, aspirations, and results (SCOAR) based on the information gathered from the survey, consultations and feedback from Township Council and staff.

There was a general discussion with respect to SCOAR and the focus group provided further information and suggestions to be taken into consideration when preparing the final report. The focus group discussed aspects that may be included to market the Township and how they view the Township in relation to affordability, facilities, accessibility, location, tourism, and other unique benefits.

The group discussed:

- What has changed within the community since the 2012 economic development strategy was development
- What positive/negative changes or new items have developed in the Township
- What are considered to be economic strengths which can be used to leverage successful future economic planning
- How the community and area is evolving
- What sectors/areas may be lacking
- Where is there opportunity for future growth and development
