BY-LAW NO. 2019-11

"A BY-LAW TO IMPOSE WATER RATES FOR USERS OF THE WATER DISTRIBUTION SYSTEM IN NEW WEXFORD, COUNTY ROAD 2 AND THE JOHNSTOWN INDUSTRIAL PARK"

WHEREAS the Municipal Act 2001, S.O. 2001, c.25, Subsection 290, as amended, provides that the council of a local municipality shall in each year prepare and adopt a budget, including estimates of all sums required during the year for the purposes of any board, commission or other body;

AND WHEREAS Section 391 of the Municipal Act, 2001, S.O. 2001 as amended provides for a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the Council of the Corporation of the Township of Edwardsburgh/ Cardinal deems it expedient to establish water rates for the Water Distribution System in New Wexford, County Road 2 and the Johnstown Industrial Park;

AND WHEREAS The Council of the Corporation of the Township of Edwardsburgh/Cardinal has enacted by-laws 2007-03, 2008-22 and 2016-94 to enter into an agreement with the Town of Prescott for the supply of potable water;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh/ Cardinal enacts as follows:

- 1. Rates and charges shall be determined in accordance with Schedule "A" attached hereto and forming part of this by-law
- 2. The rates and charges shall be effective retroactive to March 1st, 2019 upon passing of this by-law
- 3. Charges shall be billed monthly. Amount unpaid after 30 days shall be charged interest at a rate of 1.25% per month. At the discretion of the Treasurer of the municipality, outstanding accounts may be added to the collector's roll and collected in a like manner as taxes, according to Section 398(2) of the Municipal Act, 2001, SO 2001.
- 4. By-law 2015-27 of the Township of Edwardsburgh/Cardinal is hereby repealed.
- 5. This by-law shall be known at the "Industrial Park Water Rate By-law".

Schedule "A" By-law 2019- \\

WATER RATES

- 1. Rates for water shall be composed of two factors, the cost of water paid to the Town of Prescott and the cost of operating and maintain the water distribution system in the Township of Edwardsburgh/Cardinal.
- 2. Water rate per cubic meter per month are:

	Prescott	E/C	Total
1400 m ³ minimum	\$5.37	\$2.51	\$ 7.88
1401 m ³ to 5000 m ³	\$.676	\$.3169	\$.9929

- 3. Each user shall be billed a minimum monthly charge of 46.32 for six (6) cubic meters.
- 4. Each user of more than six (6) cubic meters per month shall be billed their proportionate consumption of the 1400 cubic meters minimum charge from the Town of Prescott less the minimum monthly charge for six (6) cubic meters at a rate of \$7.88 per cubic meter.
- 5. Each user of more than its proporationate share of the 1400 cubic meter minimum charge from the Town of Prescott shall be billed \$.9929 per cubic meter for the excess consumption over its proportionate share.
