Position Summery:

Reporting to the Manager of Public Works or his designate, the Equipment Operator 1 undertakes, the operation of heavy equipment, road surface, subsurface and right-ofway maintenance and construction. Roadwork includes, but is not limited to, road and side walk snow plowing and snow removal, road surface repairs, subsurface reconstruction, culvert replacements, Township infrastructure excavations, as well as use of small equipment to undertake various tasks such as chainsaws, weed trimmers, cutoff saws, hand tools, installation of signs, posts and barriers. Operators are responsible for adhering to all municipal infrastructure programs and services, undertaking daily circle checks of equipment and documenting findings. Duties include cleaning equipment and minor maintenance such as greasing. Other duties as assigned by the Public Works Manager or his designate.

Proponent must provide evidence of a clean Driver's Abstract and wear and maintain all personal protective equipment supplied by the employer when appropriate.
