## "A BY-LAW TO PROVIDE FOR A DRAINAGE WORKS IN THE TOWNSHIP OF EDWARDSBURGH CARDINAL IN THE COUNTY OF GRENVILLE"

## "NEWPORT MUNICIPAL DRAIN"

WHEREAS the United Counties of Leeds and Grenville (road authority) have petitioned the Council of the Township of Edwardsburgh Cardinal in the County of Grenville in accordance with the provisions of the *Drainage Act R.S.O. 1990*, requesting that the following lands and roads may be drained by a drainage works:

"The purpose of the proposed drain is to provide improved drainage and conveyance of flow to a sufficient outlet (as defined by the Act) for surface drainage within the County Road 2 ROW between Reilly St. and Commerce Drive."

WHEREAS the Council of the Corporation of the Township of Edwardsburgh Cardinal has received a report prepared by Robinson Consultants Inc. and the report is attached hereto and forms part of this bylaw; and

**WHEREAS** the estimated total cost of constructing the drainage works is \$1,733,328.91; and

**WHEREAS** the Council of the Corporation of the Township of Edwardsburgh Cardinal is of the opinion that the drainage of the area is desirable;

**NOW THEREFORE** the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

- 1. That the Engineer's Report for the Construction of the Newport Municipal Drain dated November 2021, and Addendum No. 1 dated January 2022, and attached hereto and forming part of this bylaw, is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized, and shall be completed in accordance therewith.
- 2. That the Corporation of the Township of Edwardsburgh Cardinal may borrow on the credit of the Corporation the amount of \$1,733,328.91, being the amount necessary for the construction of the drainage works.
- 3. That the Corporation may issue debentures for the amount borrowed less the total amount of:
  - a. Grants received under Section 85 of the Act;
  - Commuted payments made in respect of lands and roads assessed within the municipality;
  - c. Moneys paid under subsection 61(3) of the Act; and
  - Moneys assessed in and payable by another municipality;

And such debentures shall be made payable within 10 years from the date of the debenture and shall bear interest at a rate not higher than the rate charged by the Ontario Municipal Improvement Corporation on the date of sale of such debentures.

4. That a special equal amount rate sufficient to redeem the principal and interest on the debentures shall be levied upon the lands and roads as set forth in the Schedule to be collected in the same manner and at the same time as other taxes are collected in each year for 10 years after the passing of this bylaw.

- 5. For paying the amount of \$80,733.07, being the amount assessed upon the lands and roads belonging to or controlled by the municipality, a special rate sufficient to pay the amount assessed plus interest thereon shall be levied upon the whole rateable property in the Township of Edwardsburgh Cardinal in each year for 10 years after the passing of this bylaw to be collected in the same manner and at the same time as other taxes are collected.
- 6. That all assessments of \$1,000.00 or less are payable in the first year in which the assessment is imposed.
- 7. That this bylaw comes into force on the passing thereof and may be cited as the "Newport Municipal Drain Bylaw".
