BY-LAW NO. 2026-09

**“A BY-LAW TO AUTHORIZE THE MAYOR AND INTERIM CLERK
TO EXECUTE A TIERED RESPONSE AGREEMENT WITH THE
UNITED COUNTIES OF LEEDS AND GRENVILLE”**

WHEREAS the Municipal Act, 2001 provides authority for municipalities to pass by-laws to enter into agreements with persons or municipalities for the purpose of receiving fire protection services; and

WHEREAS the participation of local fire departments in tiered response for medical emergencies is set out in the attached Agreement, including Schedule “A” - Call Out Procedures, and Schedule “B” - Roles and Responsibilities; and

WHEREAS it is deemed desirable to enter in to a Tiered Response Agreement with the United Counties of Leeds and Grenville;

NOW THEREFORE: The Council of the Corporation of the Township of Edwardsburgh/Cardinal enacts as follows:

1. That the Mayor and Interim Clerk are hereby authorized to execute a Tiered Response Agreement with the United Counties of Leeds and Grenville as attached hereto;
2. That the Fire Chief is hereby authorized to execute Schedule “B” – Roles and Responsibilities as attached to the Tiered Response Agreement.
3. That Township of Edwardsburgh Cardinal By-law 2016-34 is hereby repealed.
4. That this by-law shall come into force and take effect upon passing.
