**“A BY-LAW TO AUTHORIZE THE MAYOR AND CLERK TO EXECUTE A RURAL  
ECONOMIC DEVELOPMENT PROGRAM AGREEMENT WITH HER MAJESTY  
THE QUEEN IN RIGHT OF ONTARIO AS REPRESENTED BY THE MINISTER OF  
AGRICULTURE, FOOD AND RURAL AFFAIRS”**

**WHEREAS** the Township of Edwardsburgh Cardinal has been awarded funding from the Minister of Agriculture, Food and Rural Affairs, through the Rural Economic Development Program; and

**WHEREAS** Municipal Council deems it desirable to enter into the Rural Economic Development Program Agreement with Her Majesty the Queen in Right of Ontario as represented by the Minister of Agriculture, Food and Rural Affairs.

**NOW THEREFORE** the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That the Mayor and Clerk are hereby authorized to execute the funding agreement attached hereto as Schedule “A” on behalf of the Township of Edwardsburgh Cardinal.
2. That Schedule “A” attached hereto shall form part of this by-law.
3. That this by-law shall come into force and take effect on the date of passing.
