**BY-LAW NO. 2024-11**

**"A BY-LAW TO AUTHORIZE THE EXECUTION OF A DEVELOPMENT  
AGREEMENT WITH CALVIN WAYNE POLITE AND CATHERINE SARAH  
POLITE"**

**WHEREAS** the Council of the Corporation of the Township of Edwardsburgh Cardinal is authorized to enter into a development agreement and register it against the title to the land pursuant to section 53 of the Planning Act, R.S.O. 1990; and

**WHEREAS** the Council of the Corporation of the Township of Edwardsburgh Cardinal recommended in favour of Consent to Sever Application B-52-23 conditional upon entering into a Development Agreement to the satisfaction of the Township of Edwardsburgh Cardinal to implement the recommendations and findings of the hydrogeological assessment and terrain analysis prepared by Kollaard Associates; and

**WHEREAS** the Consent to Sever Application B-52-23 has received conditional approval from the United Counties of Leeds and Grenville Consent Granting Authority; and

**WHEREAS** it is deemed expedient to enter into such a development agreement with Calvin Wayne Polite and Catherine Sarah Polite for development of lands described as the severed parcel of severance application B-52-23 of the United Counties of Leeds and Grenville, Part 1 of 15R12388; EDWARDSBURGH/CARDINAL.

**NOW THEREFORE** the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:


1. That the Mayor and Clerk are hereby authorized to execute the development agreement attached hereto as Schedule "A" and shall form part of this bylaw.
