BY-LAW NO. 2025-34

**"A BY-LAW TO IMPOSE WATER RATES FOR USERS OF THE WATER
DISTRIBUTION SYSTEM IN NEW WEXFORD, COUNTY ROAD 2 AND THE
JOHNSTOWN INDUSTRIAL PARK"**

WHEREAS the Municipal Act 2001, S.O. 2001, c.25, Subsection 290, as amended, provides that the council of a local municipality shall in each year prepare and adopt a budget, including estimates of all sums required during the year for the purposes of any board, commission or other body; and

WHEREAS Section 391 of the Municipal Act, 2001, S.O. 2001 as amended provides for a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it; and

WHEREAS the Council of the Corporation of the Township of Edwardsburgh Cardinal deems it expedient to establish water rates for the Water Distribution System in New Wexford, County Road 2 and the Johnstown Industrial Park; and


WHEREAS The Council of the Corporation of the Township of Edwardsburgh Cardinal has enacted by-laws 2007-03, 2008-22 and 2016-94 to enter into an agreement with the Town of Prescott for the supply of potable water;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. The Schedule "A" of by-law 2022-18 is hereby repealed and replaced with Schedule "A" as attached hereto and forming part of this bylaw.
2. That all other provisions of by-law 2022-18 remain in force and effect.
3. This by-law shall be known as the "Industrial Park Water Rate By-law"
4. This by-law shall come into force and take effect on the date of passing with implementation to follow as of July 1, 2025.

Read a first and second time in open Council this 30 day of June, 2025.

Read a third and final time, passed, signed, sealed in open Council this 30 day of June, 2025.

Schedule "A" - Rates & Fees
Bylaw 2025-34

Part A: Fixed Service Charge by Meter Size per Period

Each user shall be billed the monthly base rate, based on the meter size, plus \$3.85/m3 for water consumption.

Meter Size	Monthly Base Rate	Consumption Rate
3/4"-5/8"	\$29.15	\$3.85/ m3
1 1/2"-2"	\$68.75	\$3.85/ m3
4"	\$233.75	\$3.85/ m3

Part B: Flat Rate

The flat rate fees outlined within Category A, B, and C will be incorporated into the rate structure during circumstances where a meter(s) is not functioning or communicating. The Township of Edwardsburgh Cardinal has sole discretion when determining if a meter(s) is not properly functioning or communicating with the system.

	Meter Size	Formula	Monthly Bill
CateQorv A	3/4"-5/8"	\$29.15 + 10m3	\$67.65
CateQorv B	1 1/2"-2"	\$68.75 + 100m3	\$453.75
CateQorv C	4"	\$233.75 + 1000m3	\$4,083.75
