**“TO ESTABLISH PROCEDURES
FOR THE SALE OF REAL PROPERTY OWNED BY THE
MUNICIPALITY AND DEEMED TO BE SURPLUS”**

WHEREAS Section 270 (1) of the *Municipal Act*, 2001, S.O. 2001 25, as amended, requires all municipalities to adopt and maintain policies governing the sale of surplus and;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That the Sale of Surplus Land policy, as attached hereto as Schedule “A”, shall form part of this bylaw.
2. That Bylaw 2015-44 and all other bylaws previously passed that are inconsistent with the provisions of this bylaw are hereby repealed.
3. That this by-law shall come into force and effect upon passing.
