TOWNSHIP OF EDWARDSBURGH/CARDINAL
BY-LAW NO. 2011-12**

**"A BY-LAW TO LEVY AN INTERIM ASSESSMENT OF COST
FOR THE MAINTENANCE AND IMPROVEMENT OF THE
JAMES REILLY/DEWIT-RICHTER DRAIN"**

WHEREAS the Council of the Township of Edwardsburgh/Cardinal adopted By-law 2009-53 on the 4th day of August, 2009 to provide for drainage works on the James Reilly/Dewit-Richter Drain;

AND WHEREAS Section 61(1) of the Drainage Act, RSO 1990, Chapter D17 requires that a Council that is required to raise the whole or part of the cost of a drainage works shall impose upon the lands assessed for the drainage works the assessment with which it is chargeable;

AND WHEREAS Section 61(2), (3), (4) and (5) of the Drainage Act, RSO 1990, Chapter D17 authorizes the manner and means by which the charges may be levied and collected;

AND WHEREAS Section 85 of the Drainage Act, RSO 1990, Chapter D17 provides that grants may be made in respect of assessments made under this Act upon lands used for agricultural purposes;

AND WHEREAS application was made for a grant and grants are subject to available budget in the Ministry of Agriculture, Food and Rural Affairs;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh/Cardinal enacts as follows:

1. That the interim assessments of cost less applicable grants are hereby imposed on the respective properties pursuant to Schedule "A" attached hereto;
2. That the Treasurer is authorized to apply for a grant in the amount shown on Schedule "A" attached;
2. That the net cost payable shall be due and payable within thirty days of the invoice date, following which all outstanding balances in default shall be added to the Tax Collector's Roll and recovered as taxes pursuant to the provisions of the Municipal Act 2001 as amended.
3. That where the assessment against any parcel of land is \$50.00 or less, the assessment shall be paid out of general funds of the municipality;
4. That this by-law shall have force and effect upon its passage.
