- 2. That the said lands are hereby dedicated as part of the Township Road System of the Corporation of the Township of Edwardsburgh/Cardinal
- 3. That the road herein described is named Giant Tiger Boulevard.
- 4. That this bylaw shall come into force and take effect upon date of passing.
