BY-LAW NO. 2026-17

**“BEING A BY-LAW TO DESIGNATE OVERALL RESPONSIBLE OPERATORS
FOR THE WATER AND WASTEWATER SYSTEMS OF THE
TOWNSHIP OF EDWARDSBURGH/CARDINAL”**

WHEREAS it is deemed expedient to designate various positions within the Township of Edwardsburgh Cardinal Environmental Services Department.

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That the Chief Water & Sewer Operator Aaron Campbell is hereby designated as the Overall Responsible Operator for the Township of Edwardsburgh Cardinal.
2. That the Assistant Chief Water & Sewer Operator Tyler Selleck is hereby designated as the Alternate Overall Responsible Operator for the Township of Edwardsburgh Cardinal.
3. That the Director of Operations, Eric Wemerman, is hereby designed as the Alternate Overall Responsible Operator in the absence of the Chief and Assistant Chief Water & Sewer Operators for the Township of Edwardsburgh Cardinal.
4. That by-law 2024-16 and all other bylaws previously passed that are inconsistent with the provisions of this bylaw are hereby repealed.
5. That this by-law shall come into force and effect on the date of passing.

Read a first and second time this 30 day of March, 2026.

Read a third and final time, passed, signed and sealed this 30 day of March, 2026.
