

**THE CORPORATION OF THE

BY-LAW NO. 2026-18**

**“A BY-LAW TO AMEND BY-LAW 2011-30 BEING A BY-LAW TO ADOPT A
POLICY WITH RESPECT TO DELEGATION OF AUTHORITY”**

WHEREAS the Municipal Act 2001, SO 2001, c.25, Section 270(1) directs that a municipality shall adopt and maintain policies with respect to matters including the delegation of its powers and duties; and

WHEREAS Section 23.1(1) of the Municipal Act, authorizes a municipality to delegate its powers and duties subject to the restrictions set out therein; and

WHEREAS it is deemed advisable to amend the delegation of authority policy.

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That Schedule A of By-law 2011-30 is amended by adding the following:

Description	CAO & Clerk	Treasurer	Manager
Signing authority to bind the corporation for agreements under by-law, resolution and/or pursuant to tender awards or the procurement policy.	Yes	Yes	Yes – up to \$30,000

2. That all other provisions of Bylaw 2011-30, as amended, shall remain in force and effect.
3. That this bylaw shall come into force and take effect upon passing.

Read a first and second time in open Council this 30th day of March, 2026.

Read a third and final time, passed, signed and sealed in open Council this 30th day of March, 2026.
