BY-LAW NO. 2026-29

**“A BY-LAW TO AMEND 2026-26 BEING A BY-LAW TO LEVY THE FINAL
ASSESSMENT OF COST FOR THE MAINTENANCE AND IMPROVEMENT OF
THE FERGUSON MUNICIPAL DRAIN”**

WHEREAS the Council of the Township of Edwardsburgh Cardinal authorized drainage works on the Ferguson Municipal Drain in accordance with Section 74 of the Drainage Act;

AND WHEREAS Section 61(1) of the Drainage Act, RSO 1990, Chapter D17 requires that a Council that is required to raise the whole or part of the cost of a drainage works shall impose upon the lands assessed for the drainage works the assessment with which it is chargeable;

AND WHEREAS Section 61(2), (3), (4) and (5) of the Drainage Act, RSO 1990, Chapter D17 authorizes the manner and means by which the charges may be levied and collected;

AND WHEREAS Section 85 of the Drainage Act, RSO 1990, Chapter D17 provides that grants may be made in respect of assessments made under this Act upon lands used for agricultural purposes;

AND WHEREAS application was made for a grant and grants are subject to available budget in the Ministry of Agriculture, Food and Rural Affairs;

NOW THEREFORE the Council of the Township of Edwardsburgh Cardinal enacts as follows:

1. That By-law 2026-26 is amended to add the following as section 7:

“All assessments more than \$5,000.00 may be paid over 12 months with monthly payments by post-dated cheques with no interest charged, following which all outstanding balances in default shall be added to the Tax Collector's Roll and recovered as taxes pursuant to the provisions of the Municipal Act 2001 as amended.”
2. That section 6 through 8 be renumbered as 7 through 9.
3. That all other provisions of By-law 2026-26 and its Schedules shall remain in force and effect.
4. That this By-law shall come into force and take effect on the date of passing.

Read a first and second time in open Council this 11 day of May, 2026.

Read a third and final time, passed, signed and sealed in open Council this 11 day of May, 2026.
