BY-LAW NO. 2026-07

**“BEING A BY-LAW TO APPOINT A BUILDING INSPECTOR FOR THE
TOWNSHIP OF EDWARDSBURGH CARDINAL”**

WHEREAS the Building Code Act, 1992, S.O. 1992, c. 23, Section 3(2), provides that each municipality shall appoint a Chief Building Official and such inspectors as are necessary for the Enforcement of said Act in the areas in which the municipality has jurisdiction;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That Brock McPherson is hereby appointed Building Inspector for the Township of Edwardsburgh Cardinal to act on behalf of the Chief Building Official in his/her absence and that as a senior Building Official, shall perform the duties of the Chief Building Official as set out in the Building Code Act, 1992 S.O. 1992 c.23, as amended.
2. That Brock McPherson shall do all things and perform all duties of this office heretofore stated, pursuant to the statutory authority quoted heretofore.
3. That this by-law shall come into force and effect upon its passing on this 23 day of February, 2026.

Read a first and second time in open Council this 23 day of February, 2026.

Read a third and final time, passed, signed and sealed this 23 day of February, 2026.
