

**THE CORPORATION OF THE
TOWNSHIP OF EDWARDSBURGH CARDINAL**

BY-LAW NO. 2021-49

**“BEING A BYLAW TO LEVY THE ASSESSMENT OF THE BARKLEY MUNICIPAL
DRAIN”**

WHEREAS the Council of the Corporation of the Municipality of South Dundas in the County of Dundas enacted Bylaw 1974-14 in the former Township of Matilda to provide for drainage works in accordance with Section 78 of the Drainage Act on the Barkley drain;

AND WHEREAS the Council of the Corporation of the Municipality of South Dundas in the County of Dundas enacted By-law 2021-84 on August 16, 2021 to levy assessments for works performed on the Barkley municipal drain;

AND WHEREAS the drainage maintenance was completed in 2016;

AND WHEREAS some of the properties benefiting from the drainage maintenance works are within the boundaries of the Township of Edwardsburgh Cardinal;

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That the assessments of cost less applicable grants are hereby imposed on the respective properties pursuant to Schedule “A”, attached hereto and forming part of this bylaw.
2. Where the assessment against any parcel of land is \$10.00 or less, the assessment shall be paid out of general funds of the Municipality.
3. That all assessments more than \$10.00 and less than \$300.00 shall be due and payable within thirty (30) days of the invoice date, following which all outstanding balances in default shall be added to the Tax Collector's Roll and recovered as taxes pursuant to the provisions of the Municipal Act, 2001, as amended.
4. That all assessments more than \$300.00 and less than \$5,000.00 may be paid over twelve (12) months with monthly payments by post-dated cheques with no interest charges, following which all outstanding balances in default shall be added to the Tax Collector's Roll and recovered as taxes pursuant to the provisions of the Municipal Act, 2001, as amended.
5. This bylaw comes into force on the passing, thereof and may be cited as the “Barkley Drain Bylaw”.

THE CORPORATION OF THE MUNICIPALITY OF SOUTH DUNDAS

BY-LAW NO. 2021-84

A BY-LAW to amend Schedule "A" to By-Law No. 2021-31 to assess the maintenance costs of the Barkley Municipal Drain.

WHEREAS the maintenance works requested are now complete and the accumulated costs are \$34,210.50;

AND WHEREAS it has been identified that agricultural grants had been applied to properties in the Township of Edwardsburgh/Cardinal that were not eligible;

AND WHEREAS it is necessary to levy the respective costs in the same proportion as authorized in construction By-Law No. 74-14 of the former Township of Matilda.

NOW THEREFORE the Council of the Corporation of the Municipality of South Dundas enacts as follows:

1. The amended assessments as detailed in Schedule "A" are hereby levied on the applicable properties and are due and payable on or before May 31, 2021.
2. Late payments will accrue interest at the prevailing tax rate of 1.25% per month.
