

**THE CORPORATION OF THE
TOWNSHIP OF EDWARDSBURGH/CARDINAL
BY-LAW NO. 2011-03**

**"A BY-LAW TO LEVY THE FINAL ASSESSMENT OF COST
FOR THE MAINTENANCE OF THE THORPE ELLIS DRAIN"**

WHEREAS the Township of South Dundas adopted By-law 2010-84 on the 10th day of November, 2010 to assess the final costs for the maintenance of the Thorpe Ellis Drain;

AND WHEREAS Section 61(1) of the Drainage Act, RSO 1990, Chapter D17 requires that a Council that is required to raise the whole or part of the cost of a drainage works shall impose upon the lands assessed for the drainage works the assessment with which it is chargeable;

AND WHEREAS Section 61(2), (3), (4) and (5) of the Drainage Act, RSO 1990, Chapter D17 authorizes the manner and means by which the charges may be levied and collected;

AND WHEREAS lands within the municipality of the Township of Edwardsburgh/Cardinal was assessed under By-law 2010-84 of the Township of South Dundas;

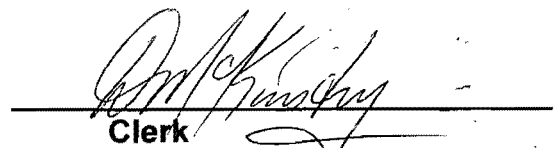
NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh/Cardinal enacts as follows:

1. That the assessments of cost less applicable grants are hereby imposed on the respective properties pursuant to Schedule "A" attached hereto;
2. That the net cost payable shall be due and payable within thirty days of the invoice date, following which all outstanding balances in default shall be added to the Tax Collector's Roll and recovered as taxes pursuant to the provisions of the Municipal Act 2001 as amended.
3. That where the assessment against any parcel of land is \$50.00 or less, the assessment shall be paid out of general funds of the municipality;
4. That this by-law shall have force and effect upon its passage.

Read a third and final time, passed, signed and sealed in open Council this 17th day of January, 2011.
