BY-LAW NUMBER 2026-38
“A BY-LAW TO APPOINT A DEPUTY CLERK”**

WHEREAS *the Municipal Act, 2001* S.O. 2001, c. 25, Section 228(2) states that a municipality may appoint deputy clerks who have all the powers and duties of the clerk under this and any other Act; and

WHEREAS it is deemed desirable to appoint a Deputy Clerk who will be able to perform such duties as are required in the absence of the Clerk.

NOW THEREFORE the Council of the Corporation of the Township of Edwardsburgh Cardinal enacts as follows:

1. That Laura Stanzel is hereby appointed Deputy Clerk for the Township of Edwardsburgh Cardinal.
2. That Laura Stanzel shall do all things and perform all duties of this office heretofore stated, pursuant to the statutory authority quoted heretofore.
3. That By-law 2026-15 is hereby repealed.
3. That this By-law shall come into force and take effect upon passing.
